Dear Colleague

We are writing to you in the capacity of co-convenors of the steering group for the London Hearing of the Permanent Peoples' Tribunal on the Violations with Impunity of the Human Rights of Migrant and Refugee Peoples.

You may know that the Permanent Peoples' Tribunal (PPT) structure grew from the precedent of the Russell Tribunal on Vietnam (1966-67) and Latin America (1973-76). It is based in Rome, at the Fondazione Lelio e Lisli Basso, Via della Dogana Vecchia 5. Please visit its website at for more information.

The session of the PPT on the violation of the rights of migrants and refugees was launched in Barcelona on 8th July 2017. Since then three further hearings have taken place, in Palermo, Italy in December 2017, Paris, France in January 2018 and Barcelona in June 2018. The record of these hearings can be seen on the PPT website.

The Hearing in London will convene before a panel of international judges. The panel will consider an indictment, which sets out charges against UK authorities for violating the rights of migrants and refugees. The current version of the indictment is appended to this letter.

The purpose of this request is to ask whether your organisation could register its support for the London hearing by agreeing to join our list of sponsoring organisations.
